Faculty of Law:

Following the opinion of the Faculty Council of the Faculty of Law on 14.06.2017 and the Senate on 09.08.2017, the Presidential Board approved the Regulations about the charging of fees for the postgraduate Master's degree programme on 15.08.2017 (§§ 13 section 3 and 9, 37 section 1 sentence 3, 41 section 2 sentence 2, 44 section 1 sentence 2 NHG in the version published on 26.02.2007 (Nds. GVBl. p. 69), last amended by Article 4 of the Act on 15.06.2017 (Nds. GVBl. p. 172) in conjunction with §§ 2 section 1, 3 section 3 and number 1.1.1. of the appendix 1 of the Regulation of fees and charges of the Georg-August-Universität Göttingen/Georg-August-Universität Göttingen Public Law Foundation in the version published on 03.04.2008 (Official Announcements 9/2008 p. 477), last amended by decision of the Presidential Board on 16.03.2016 (Official Announcements I no. 16/2016 p. 417)).

**Regulations about the charging of fees
for the postgraduate Master's degree programme
„European and Transnational Intellectual Property and Information Technology Law“**

§ 1 Charging of fees, scope

(1) ¹The Georg-August-Universität Göttingen (hereinafter: university) charges students who are enrolled or re-registered in the postgraduate Master's degree programme "European and Transnational Intellectual Property and Information Technology Law" fees for the teaching-related services of the university in relation to the degree programme within the meaning of § 13 section 3 NHG. ²The amount and due date of the fees are set out in §§ 2 to 4.

(2) ¹Students shall bear any additional costs incurred as a result of attending the degree programme, in particular in connection with the procurement of study materials, excursions and travel expenses. ²These additional costs are not covered by the fees.

(3) ¹This does not affect the levying of further charges and fees based on other legal provisions. ²This applies in particular to the administration fee as well as the Studentenwerk and student body fees, which are levied on all students on a semester basis.

§ 2 Amount of fees

(1) Subject to sections 2 to 3 and § 3, the amount of fees up to graduation for a two-semester

course (standard period of study) is EUR 7,800.

(2) The fees according to section 1 are reduced depending on the date of receipt of the application for a study place and amount to

a) EUR 7,200 if the application is received before January 1,

b) EUR 7,500 if the application is received before April 1.

(3) If the two-semester standard period of study is exceeded, a fee of EUR 100 will be charged from the third semester onwards for the additional supervision costs incurred by the university.

(4) ¹The fees for the first two semesters include the use of a total of up to twelve modules (including the first examination attempt for the module examination), including up to four modules as part of voluntary additional examinations, as well as the supervision and assessment of the Master thesis in the first examination attempt. ²For the use of modules beyond this and the use of modules (including module examinations) from the third semester onwards, fees must be paid in accordance with § 3.

(5) ¹The fees in accordance with sections 1 and 2 must be paid upon acceptance of the study place. ²In justified exceptional cases, only half of these fees must be paid upon acceptance of the study place, while the other half must be paid by the end of the re-registration period for the second semester at the latest. ³If the application for enrollment is rejected, any fees paid must be refunded. ⁴The deadlines for re-registration are set out in the matriculation regulations. ⁵Enrolment or re-registration without payment of the fees due is excluded.

§ 3 Fees for repeat examinations and additional modules

(1) Für die Inanspruchnahme von Wiederholungsprüfungen zu nicht bestandenen Prüfungsleistungen, von über die nach § 2 Abs. 4 zulässige Anzahl hinaus wahrgenommenen freiwilligen Zusatzprüfungen sowie die Inanspruchnahme von Modulen nach Ablauf der Regelstudienzeit werden zusätzliche Gebühren wie folgt erhoben:

(1) Additional fees shall be charged as follows for the use of repeat examinations for failed examinations, for voluntary additional examinations taken in excess of the number permitted under § 2 section 4 and for the use of modules after the standard period of study has expired:

a) EUR 100 for the use of a repeat examination,

b) EUR 500 for the supervision and assessment of the Master thesis in the second examination attempt

c) EUR 600 for each additional use of a module.

(2) Module examinations for elective compulsory or elective modules that are taken for the first time within the standard period of study in place of a failed elective compulsory or elective module are also deemed to be repeat examinations within the meaning of section 1.

(3) The fees in accordance with section 1 are due upon registration for the respective examination, but at the earliest after invoicing by the university.

§ 4 Fees for crediting services

(1) ¹The university shall charge a fee of EUR 100 per course for the processing of an application for credit transfer of other university or non-university courses in this degree programme for which credit transfer is requested; the fee shall be due after invoicing by the university. ²The fee pursuant to sentence 1 may be waived if an application for credit transfer is rejected.

(2) ¹If other academic or non-academic examinations in this degree programme are credited, a partial reimbursement of fees in accordance with § 2 section 1 may be made upon application. ²In this case, EUR 500 will be reimbursed for each module examination credited; the application must be submitted to the programme office of the degree programme. ³At the same time, the number of modules covered by the fee in accordance with § 2 section 4 is reduced by one module.

§ 5 Entry into force

(1) These regulations shall enter into force on the day following their publication in the Official Announcements I of the Georg-August-Universität Göttingen.

(2) Fees in accordance with these regulations will be charged for the first time from the winter semester 2017/2018.
